Javier A Juarez (MA Brown University '18, BA Rhode Island College '17) is a community outreach member at the Coalition for Advocates for Student Opportunities (CASO) in Providence, Rhode Island, a non-profit organization that focuses on the betterment of undocumented and first-generation immigrant students around the country. Javier has shared his experience as an undocumented student from community college to an ivy league university to raise awareness on 1st generation, low income, DACAmented/undocumented student issues. His advocacy efforts, workshops and trainings have led to progressive policies at universities like Harvard, Stanford, Brown University, and Providence college. Javier's research and teaching interest include: immigration and refugee studies; higher education, social movements; and law and society. Due to his advocacy efforts, Javier was selected as the graduate orator at Brown University's 250th Masters ceremony, Providence's TEDx series and was awarded the Vital Contribution to the Community award in 2017 at Rhode Island College. Javier is also finishing a yearlong fellowship at Trinity University alongside 30 other Dreamers from around the country that were put together to collaborate on ideas and serve as a leadership cohort to their communities. As a Dream Lead Fellow, Javier has been invited to speak at different universities around the country to motivate students and guest lecture classes on higher education and its importance to 1st generation students. Javier plans to apply to Harvard Law School in the fall of 2019 and achieve his dream of becoming an attorney to begin working on new immigration reform.
